# RULES & REGULATIONS

Every class offered herein which is covered by the rules and specifications of the current federation rule book and current FEI rules will be conducted and judged in accordance therewith.

## 2026 USEF MEMBERSHIP STATEMENT

Life, senior active and junior active members shall be eligible to participate in all classes at Regular Competitions, Eventing Competitions at the Modified Level or above and Combined Driving Competitions at the Advanced Level, Dressage, Reining and Vaulting Competitions and Endurance Rides. A non-member may participate as a handler, rider, driver, owner, lessee, or agent, at Regular Competitions, Eventing Competitions, Dressage Competitions, Reining Competitions and Combined Driving Competitions upon payment of a Show Pass fee. Participants in the following classes are exempted from the Requirements of this rule: 1) leadline; 2) exhibitions; 3) games and races; 4) classes for 4-H members; 5) walk trot and academy classes (academy classes are classes limited to horses used regularly in a lesson program); 6) USDF introductory level tests, pas de deux and quadrille classes; 7) assistant handlers in Dressage Sport Horse Breeding classes.

## FEDERATION ENTRY AGREEMENT

By entering a Federation-licensed Competition and signing this entry blank as the Owner, Lessee, Trainer, Manager, Agent, Coach, Driver, Rider, Handler, Vaulting or Longeur and on behalf of myself and my principals, representatives, employees and agents, I agree that I am subject to the Bylaws and Rules of The United States Equestrian Federation, Inc. (the "Federation") and the local rules of competitions listed herein. I agree to be bound by the Bylaws and Rules of the Federation and of the competition. I will accept as final the decision of the Hearing Committee on any question arising under the Rules, and agree to release and hold harmless the competition, the Federation, their officials, directors, and employees for any action taken under the Rules. I represent that I am eligible to enter and/or participate under the Rules, and every horse I am entering is eligible as entered. I also agree that as a condition of and in consideration of acceptance of entry, the Federation and/or the Competition may use or assign photographs, videos, audios, cable - casts, broadcasts, internet, film, new media or other likenesses of me and my horse taken during the course of the competition for the promotion, coverage or benefit of the competition, sport, or the Federation. Those likenesses shall not be used to advertise a product and they may not be used in such a way as to jeopardize amateur status. I hereby expressly and irrevocably waive and release any rights in connection with such use, including any claim to compensation, invasion of privacy, right of publicity, or to misappropriation. The construction and application of Federation rules are governed by the laws of the State of New York, and any action instituted against the Federation must be filed in New York State. See GR908.4.

If not currently a USEF Active Competing member or Subscriber, I acknowledge that I will be enrolled for no cost as a USEF Fan and my USEF Fan Account will continue to annually automatically renew in the USEF's sole discretion. Additionally, I acknowledge that the benefits of a USEF Fan are subject to change without notice. USEF may in its sole discretion, at any time, terminate my USEF Fan status. I acknowledge that I may opt out at any time by going to My USEF Dashboard or calling (859)810-8733.

## SAFE SPORT STATEMENT

All USEF Life and Senior Active member, as well as participants who have regular contact with minor athletes, are required to comply with the U.S. Center for SafeSport training requirement to be eligible to participate in the competition. All participants must adhere to the U.S. Center for SafeSport Code, USEF Safe Sport Policy, and the Minor Athlete Abuse Prevention Policies. More information about these can be found at [www.usef.org](http://www.usef.org). Junior riders who have reached their 18th birthday must complete Safe Sport training.

# RULES & REGULATIONS

## BROWNLAND FARM SHOW POLICIES

The Horse Show Management reserves the right to itself interpret all questions and conditions in regard to, or arising out of, or incident to the Show without claims for damages or recourse of any kind. All questions not covered in these Rules & Regulations shall be decided by Show Management, it's decision to be final.

The Horse Show Management reserves to itself the right to refuse, accept conditionally, or to cancel any entries, disqualify any riders or exhibitors, prohibit exhibition of entries, and cancel award prizes, without claim for damages; to change any course, to cancel or combine any classes, or to reschedule classes after due notice to exhibitors; to change rings or rotate judges; use dotted lines; and to change the specifications in jumper classes as competition warrants.

Every horse entered herein for competition will be under control of the Show Management, but the Show Management will in no case be responsible for any loss or damage that may occur, and it shall be a condition of entry that each exhibitor shall hold the Horse Show, officials, employees, officers, director, sponsors, and Facility Owners blameless for any loss or accident to his horse(s), employees, or equipment.

All owners and exhibitors shall be responsible for any loss or damage incurred by them, their agents or employees, to stalls, buildings and other properties on the showgrounds, and shall be billed accordingly.

## CONDITIONS & SPECIFICATIONS

### STALLS

410 permanent stalls, 12'x10', natural floors, with doors will be available at Brownland Farm at a cost of \$300 per stall, beginning Monday of the show week. No initial bedding is provided. Stalls are assigned strictly on a first come first served basis and will not be reserved without payment. Payment must received before entry deadline or stalls will be canceled. Move in Monday after 2:00pm unless other arrangements made through [bffeedstore@gmail.com](mailto:bffeedstore@gmail.com). As a service to our customers, we will split tack stalls between accounts if notified before noon Friday. Complimentary night watch is provided. Each horse will be checked at night during the show.

### ENTRY GUIDELINES

All entry forms must be completed via [HorseShowsOnline.com](http://HorseShowsOnline.com). This includes signing a USEF entry agreement.

HJ106.2: ALL HORSES, REGARDLESS OF SHOWING OR NON-SHOWING, ARE REQUIRED TO SUBMIT AN ENTRY WITH THE HORSE SHOW OFFICE AND WEAR OR DISPLAY THE BACK NUMBER AT ALL TIMES. ANY HORSE WITHOUT A BACK NUMBER OR WITH AN INCORRECT BACK NUMBER WILL BE ASKED TO LEAVE THE AREA.

**Closing date:** Entries close 2 weeks prior to the 1st day of each show series. Entries received after this date will incur a \$60 late fee.

Numbers will not be issued to competitors without credit card information or a signed open check; all health credentials provided to the horse show office; and completion of an IRS W-9 form for anyone who will be accepting prize money for horses competing in any class offering prize money.

### OFFICE

A \$70 office fee will be charged for all horses.

For your convenience we accept Visa, MasterCard, Discover and American Express. A 3% convenience fee will be added to all credit card transactions.

**Office Hours:** Office opens Wednesday-Sunday 1 hour before showing. Office closes at 5pm daily or 30 minutes after the last class finishes, whichever comes first. Adds for the next day must be completed by 4pm.

**Adds/Scratches:** There are no fees for adds/scratches. Adds/scratches must be made in the office on the official add/scratch form. All adds/scratches must be made before the start of the class.

### REFUNDS

Before the entry deadline, all fees will be refunded. After the entry deadline, stall fees, office fees, and camper fees cannot be refunded.

### NON-SHOWING HORSES

Non-showing horses will be charged a non-showing fee of \$75 per horse.

### FEDERATION FEE

(GR407.1-3) For every horse participating in any competition licensed by the Federation, a \$23 Federation Fee will be collected (\$15 shall be an Equine Drugs & Medication Fee to provide for research, inspection, and enforcement of rules regarding used of medications and drugs & \$8 USEF Fee). Each horse entered will also be required to pay a \$10 USHJA Fee and a USHJA Showpass \$30 fee will be collected for any person who is not a current USHJA member. USEF Membership is required.

# CONDITIONS & SPECIFICATIONS

## CHECK-OUT

Any horse show bill not checked out at the conclusion of each show will be assessed a \$65 fee for check out. Any mistakes at the checkout must be resolved within 24 hours.

## NON-NEGOTIABLE CHECKS

Checks returned by the bank for any reason will be assessed a penalty of \$100, or 10% of the check amount, whichever is greater. Upon notification of a returned check, accounts will be given three (3) days to make full payment including the penalty, which must be paid in certified funds, cashier's check or money order. Overnight mail service is advised in order to avoid notification of the sanctioning organizations for disciplinary action.

## GROUNDS FEE

There is a \$75 fee for horses without a stall and day haulers that are competing in the show.

## PRIZE MONEY

Prize money to be distributed as follow: 30%, 22%, 15%, 13%, 11%, 9% (except as noted). Prize money will be applied to your horse's account. No money will be awarded without providing the show office with a SSN/EIN, email and physical address, and a signed W-9 form if requested. Prize money will be awarded within 30 days of the close of competition. UNDEPOSITED/UNCASHED CHECKS ARE VOID AFTER 90 DAYS.

## DIVISION/SECTION

A division will not be split unless there are 6 or more entries for each section. A division will not be held unless there are at least 4 entries.

## CHAMPIONSHIPS

Champion & Reserve will be awarded in all Hunter sections except schooling and special classes; and in all Jumper sections except classics, Grand Prix, and Young Jumper classes.

## STARTERS, JUMP ORDER & CONFLICTS

A rotating jump order will, at management's discretion, be established for jumping classes. Rings will not be held to wait for horses and/or riders. Riders who anticipate a conflict must arrange their order of go to avoid causing a delay.

## EARLY ARRIVALS

Any stall used prior to the Sunday before the competition starts will be charged \$45 per night (lay-over rate). Any Camper/RV arriving early will also be charged \$45 per night. Camper/RVs may park early in trailer parking at no cost. All early arrivals must email the stable manager at [bf.feedstore@gmail.com](mailto:bf.feedstore@gmail.com) prior to arrival.

## FEED & BEDDING

Feed, hay, and bagged shavings will be available on the show grounds and may be charged to your horse's account.

## CAMPER HOOKUPS

There are a limited number of camper hookups available. Camper reservations available online only at [stallinfo.net/brownland-farm-horse-show](http://stallinfo.net/brownland-farm-horse-show). Camper fee is \$375 + tax and may be billed to horse show account. Phone number to call for waste removal is available at show office. No dumping of any wastewater is allowed. \$500 fine for not abiding by this rule.

## TURNOUT PADDOCKS

Small paddocks are \$300; large paddocks are \$600. Horses may not be turned out without first contacting the Stable Manager and receiving your paddock assignment. Small paddocks, no more than 1 horse at a time.

## POLING

No manual poling or offsets allowed on Brownland Farm Showgrounds.

## SCHOOLING

Ticketed warm up will be on Tuesday. Dismounted, hand-walking may be permitted before the show starts each day, AT MANAGEMENT'S DISCRETION.

## FOOTING & RINGS

The Grand Prix and jumper schooling rings have Trutex Oasis footing. The Grand Prix arena is 330'x192'. The hunter show rings and schooling ring are a mixture of limestone and sand. The hunter show rings are 275'x135' and the main hunter warm-up ring is 300'x200'.

## PARKING

All vehicles, including trailers, vans and campers are prohibited from being parked in the stale areas. Vans and trailers will be allowed in the stable areas only for loading/unloading. PARKING AREAS ARE DESIGNATED.

## RADIOS

Barns who use hand held radios that are on the show radio frequency, or that interfere with show radios in any way will be required to discontinue the use of their radios during show hours.

## REFRIGERATORS

No refrigerators/freezers allowed in the stable area. MANAGEMENT RESERVES THE RIGHT TO UNPLUG AT ANY TIME.

### **ACCIDENTS INVOLVING COMPETITORS**

GR1317. In the event of a head injury due to a fall/accident at a licensed competition, the competitor may be prohibited from further competition until released by medical personnel. In some cases, the competitor may not return to competition without a signed release from a licensed medical professional. The competitor may be placed on suspension by USEF until this criterion is met.

### **PROTECTIVE HEADGEAR**

It is compulsory for all persons at Federation licensed hunter/jumper competitions when mounted anywhere on the competition grounds, to wear properly fastened protective headgear which meets or exceeds ASTM (American Society for Testing and Materials)/SEI (Safety Equipment Institute) standards for equestrian use and carries the SEI tag. It must be properly fitted with harness secured. It is the responsibility of the rider, or the parent, guardian or trainer of the junior exhibitor to see to it that the headgear worn complies with appropriate safety standards and is properly fitted and in good condition.

### **MOTORIZED VEHICLES**

Minors who do not have a valid driver's license which allows them to operate a motorized vehicle in the state in which they reside will not be permitted to operate a motorized vehicle of any kind, including, but not limited to, golf carts, motorcycles, scooters, or farm utility vehicles, on the competition grounds of licensed competition. Minors who have a valid temporary license may operate the above described motorized vehicles as long as they are accompanied by an adult with a valid driver's license. The parent/legal guardian or individual who signs the entry blank as a parent or guardian of a minor operating a motorized vehicle in violation of this rule are solely responsible for any damages, claims, losses or actions resulting from that operation. Violations of this rule will be cause for penalties against those responsible for the child committing the offense. Wheelchairs and other mobility assistance devices for individuals with disabilities are exempt from this rule. The unsafe use of personal electronic transport devices, as determined by the competition officials and management in their sole discretion, that do not require a driver's license to operate, including but not limited to segways, hoverboards, and single wheeled scooters is prohibited on competition grounds. Operating such devices in areas where people

gather may be deemed "unsafe use" if there is a risk of harm to others. If the operator of the device is a minor, the parent/legal guardian or individual who signs the entry blank as a parent or guardian of a minor operating the device in violation of this rule is accountable and may be subject to penalties. Wheelchairs and other mobility assistance devices for individuals with disabilities are exempt from this rule.

### **DOGS**

Dogs are not permitted to be loose on the competition grounds. Dog owners are solely responsible for any damage, claims, losses, or actions resulting from their dog's behaviors. Dog owners failing to comply with this rule may be subject to a \$100 fine. Further offense(s) or failure to pay the fines may result in the owner being expelled from the showgrounds. If this happens, the owner will not be entitled to any refunds of entry or stabling fees paid or due. Management reserves the right to call Animal Control.

## **VETERINARY**

### **SHARPS CONTAINERS**

CR1201.4 Sharps containers are provided in the stabling areas. Competition management may fine any individuals, including trainers, owners, exhibitors, or their agents up to \$500 for improper disposal of needles or other sharp disposable instruments.

### **HEALTH REQUIREMENT**

Every horse that enters the ground must present the Health Entry Requirements which include negative Coggins, Proof of Vaccination, and Health Certificate (for out-of-state horses). All horses are subject to examination by Show Officials and/or State Officials. If officials have reason to believe that an animal's health condition places other animals at risk, the animal in question may be quarantined or, if appropriate, require that animal to be transported off the grounds. Any horse with a temperature of 101.5+ must be reported to show veterinarian. Upon veterinary examination, if diagnostic testing is deemed necessary, testing will be conducted at owner's expense. If veterinarian suspects infectious disease after inspection, the horse will be required to go into isolation or off property. All participants agree to fully cooperate with the event officials and abide by their decisions and instructions. Failure to comply shall be grounds for immediate expulsion and potential disciplinary action by the organization, state/local or federal animal health officials.

No more than eight shall be asked to hand gallop at one time.

**Minimum entry requirements:** Management reserves the right to combine Sections with less than six entries. No split Section will be held with less than four entries. Handy Hunter Courses and jumps to simulate those found in trappy hunt country, and may include natural obstacles, a trot fence and a fence to lead over.

**Jogging For Soundness:** Trotting a circle at the end of a round to demonstrate soundness is now required for Equitation, Adult Amateur, Low Adult Amateur, Children's Hunter, Low Children's Hunter, Low Children's Hunter Pony, and USHJA Hunter Sections in addition to all 'A' rated hunter divisions. X - Model

The first round score for the classic will count 50% of the total. Top twelve first round scores return for the second round. Brownland Farm, LLC strives to provide the safest environment possible for all exhibitors, both equine and human, to enjoy their horse show experience. We have implemented these biosecurity protocols to reduce the risk of introducing and/or spreading contagious or infectious diseases on the showgrounds.

### **ALL HORSES ENTERING THE SHOWGROUNDS, WHETHER SHOWING, NON-SHOWING OR SIMPLY TO SCHOOL MUST PROVIDE THE FOLLOWING:**

**NEGATIVE COGGINS:** A current (withing 365 days of arrival on showgrounds) negative Coggins test is required, INCLUDING horses that originate from Tennessee. The Coggins MUST be presented to the show secretary upon arrival and a copy must be kept at the barn with the animal.

**PROOF OF VACCINATION:** Per USEF GR-845 Equine Vaccination Rule: At Federation Licensed Competitions, horses entering the grounds must be accompanied by documentation of Equine Influenza Virus & Equine Herpes Virus (Rhinopneumonitis) vaccinations withing six (6) months of entering the stables. If a vaccination will expire during the show, the horse must receive it's new vaccination prior to being issued a competition number for that show. Current vaccination against WNV, EE, WEE, Tetanus and Rabies is strongly recommended.

**HEALTH CERTIFICATE:** A Health Certificate must be signed by a licensed veterinarian withing 21 days prior to arrival on the show grounds.

THESE DOCUMENTS ARE REQUIRED FOR ALL HORSES ENTERING THE SHOW GROUNDS, BOTH SHOWING AND NON-SHOWING. THE DOCUMENTS MUST BE FILED IN THE SHOW OFFICE BEFORE ANY NUMBERS WILL BE ISSUED. ALL HORSES ON THE SHOWGROUNDS, BOTH SHOWING AND NON-SHOWING, MUST HAVE AN ASSIGNED NUMBER. RANDOM CHECKS FOR EQUINE HEALTH REQUIREMENTS WILL OCCUR. COPIES OF THE HEALTH RECORDS MUST BE EASILY ACCESSIBLE TO ENSURE YOU CAN COMPLY WITH THIS REQUIREMENT.

ALL SHIP-INS/DAY HAULERS MUST FILE THE PROPER HEALTH REQUIREMENTS IN THE SHOW OFFICE. THEY MUST BE PREPARED TO SHOW THESE DOCUMENTS AT ANY TIME WHILE ON THE SHOWGROUNDS. SHIP-INS/DAY HAULERS WILL BE SUBJECT TO RANDOM CHECKS BY OFFICIALS AND THE DEPARTMENT OF AGRICULTURE. IF PROPER RECORDS ARE NOT IMMEDIATELY AVAILABLE, THE HORSE(S) MUST REMAIN UNDER BROWNLAND STAFF OBSERVATION UNTIL THE PAPERWORK IS PRESENTED, OR THEY WILL BE ASKED TO LEAVE THE GROUNDS.

ANY HORSE WITH A TEMPERATURE OF 101.5+ MUST BE REPORTED TO OFFICIAL SHOW VETERINARIAN. UPON EXAMINATION, IF DIAGNOSTIC TESTING IS DEEMED NECESSARY, TESTING WILL BE CONDUCTED AT OWNER'S EXPENSE. IF VETERINARIAN SUSPECTS INFECTIOUS DISEASE AFTER INSPECTION, THE HORSE WILL BE REQUIRED TO GO TO ISOLATION OR OFF THE PROPERTY.

For and in consideration of United States Equestrian Federation, Inc. dba US Equestrian ("USEF") allowing me, the undersigned, to participate in any capacity (including as a rider, driver, handler, vaulter, longeur, lessee, owner, agent, coach, official, trainer or volunteer) in a USEF sanctioned, licensed or approved event or activity, including but not limited to equestrian clinics, practices, shows, competitions and related or incidental activities and Brownland Farm Horse Shows ("USEF Event" or "USEF Events"); I, for myself, and on behalf of my spouse, children, heirs and next of kin, and any legal and personal representatives, executors, administrators, successors, and assigns, hereby agree to and make the following contractual representations pursuant to this Agreement (the "Agreement"):

A. RULES AND REGULATIONS: I hereby agree that I have read, understand, and agree to be bound by all applicable Federation Bylaws, rules, and policies including the USEF Safe Sport Policy and Minor Athlete Abuse Prevention Policies (MAAPP) as published at www.usef.org, as amended from time to time.

B. # 2026 ZONE 4 HUNTER, JUMPER, AND EQUITATION SPECIFICATIONS

(AL, FL, GA, MS, SC, TN)

In accordance with GR 1111.4: Contiguous states are: AR, KY, LA, MO, NC, VA

Judging for all Hunter Sections:

- To be judged on performance and soundness, suitability to count.
- Horses and Ponies are not required to jog for soundness.

Eligibility for Adult Amateurs: Hunter, Jumper, and Equitation:

- To be ridden by exhibitors who have reached their 18th birthday as of December 1 of the current competition year and who hold a current USEF Amateur certification. Open to horses and ponies.

Eligibility for Children's Sections: Hunter, Jumper, and Equitation:

- To be ridden by exhibitors who have not reached their 18th birthday as of December 1 of the current competition year.

## ADULT AMATEUR HUNTER

Sections offered and requirements: Adult Amateurs may be split into three (3) sections.

Cross Entry:

Rider: Riders in this sections may enter any Equitation class. Riders who compete in the Amateur Owner Hunter classes may only show other horses that they own in the Adult Amateur Hunters. Exception: Riders competing in the Amateur Owner 3'3" section (but not competing in the Amateur Owner 3'6" section) may ride one horse that they do not own in the Adult Amateur Hunter section. Adult Amateur Hunter Riders may cross enter into any Jumper Class 1.20m or below. Adult Amateur Hunter Riders may not cross enter into any Jumper class above 1.20m that offers prize money at the same show.

Horse: Horses and ponies exhibiting in this section may cross enter multiple sections of Adult Amateur Hunter and any classes where eligible.

Fence Height:

3'0" with spreads not to exceed the fence height.

Courses will not be adjusted for ponies.

In and outs will be permitted.

Combining/Dividing Sections:

May be split into three sections:

Adult Amateurs 18-35

Adult Amateurs 36-54

Adult Amateurs 55 & Over

The Adult Amateur Hunter section may be divided by age of rider and/or height of fences. If there are fewer than three (3) entries in a section, that section must be combined with another Adult Amateur section. The Adult Amateur Hunter section may be combined with the Children's Hunter section when there are fewer than three (3) entries in either section. When sections are combined and there are more than 24 total entries, the sections must be divided utilizing a Floating split, or a California split to create an even division of entries.

Classics: Adult Amateur Hunter Classics

Four (4) entries are required to conduct an Adult Amateur Hunter Classic. If there are fewer than Four (4) entries an any one Adult Amateur Hunter Classic, it may combine with other sections of Adult Amateur Hunters or Children's Hunter Horse. If Adult Amateur Hunter Classics are combined and a horse is show in more than one section qualifying for the Adult Amateur Hunter Classic, the exhibitor must declare their point section to the Competition Secretary on a declaration form at the time of entry into the classic.

Adult Amateur Hunter Classics cannot be divided in any manner and held by section if there are fewer than six (6) entries in each divided section.

Awards: Zone Horse of the Year Awards will be presented annually to the following sections:

Adult Amateur Hunter 18-35

Adult Amateur Hunter 36-54

Adult Amateur Hunter 55 & Over

## LOW ADULT AMATEUR HUNTER

**Eligibility:** Open to exhibitors who have reached their 18th birthday as of December 1 of the current competition year.

**Cross Entry:**

**Rider:** Riders may not cross enter into any class or section at the same competition where fences exceed 3'3" (Exception: Riders may cross enter all Equitation classes and Jumper classes 1.15m and below). Riders who compete in the 3' Adult Hunters and/or the 3'3" Amateur Owner Hunter classes may show horses that they own in the Low Adult Hunters and one that they do not own in the Low Adult Hunters.

**Horse and Rider Combination:** Low Adult Amateur Hunter horse/rider combinations may not cross enter into any classes or section where fences exceed 2'9".

**Fence Height:**

2'6"

**Combining/Dividing Sections:**

The Low Adult Amateur Hunter section may be combined with the Low Children's Hunter section when there are fewer than four (4) entries in either section. If sections are combined and there are more than 24 total entries, the sections must be divided utilizing a Floating split, or a California split to create an even division of entries.

**Awards:** Zone Horse of the Year Awards will be presented annually to the following sections:

## ADULT AMATEUR JUMPER

**Sections offered and requirements:**

1.00m/1.05m Amateur Jumpers

1.10m/1.15m Amateur Jumpers

**Cross Entry:**

Competition Management may restrict cross entries between 1.10m/1.15m and 1.00m/1.05m sections at the same competition if stated in the prize list.

**Rider:** Any competitor that competes in any class set at over 1.25m is ineligible to compete in an Amateur Jumper class set below 1.20m at that competition. Competitors competing in a 1.00m/1.05m Amateur Jumper Classic or a 1.10/1.15m Amateur Jumper Classic may not compete in any other Jumper Classic above 1.15m at the same competition.

**Horse and Rider Combinations:** 1.00m/1.05m Amateur Jumper horse/rider combinations may not cross enter into any classes held above 1.15m at the same show. 1.00m/1.05m Amateur Jumper horse/rider combinations may enter only one classic, if both 1.00m/1.05m and 1.10m/1.15m are offered.

1.10m/1.15m Amateur Jumper horse/rider combinations are not permitted to cross enter into Amateur Owner Jumper classes or any class at 1.20m and above, these horse/rider combinations are also not permitted to cross enter any jumper classes at 1.20m and above that offers prize money at the same competition. 1.10m/1.15m Amateur Jumper horse/rider combinations may enter only one classic, if both 1.00m/1.05m and 1.10m/1.15m are offered.

**Fence Height:**

Amateur Jumper 1.00m to 1.05m

Amateur Jumper 1.10m to 1.15m

**Combining/Dividing Sections:**

Junior Jumper sections may be divided by or combined with Amateur Jumper sections, at management's discretion, if so stated in the prize list.

**Awards:** Zone Horse of the Year Awards will be presented annually to the following sections:

1.00m/1.05m Amateur Jumper

1.10m/1.15m Amateur Jumper

## AGE GROUP EQUITATION: ADULT SECTION

**Sections offered:** Adult Equitation 18-35 and Adult Equitation 36 & Over

**Cross Entry:** No cross-entry restrictions

**Fence Height:**

Minimum 2'9", maximum 3'3" - management must state height at which class will be offered.  
Management may offer multiple height options if stated in the prize list, but each course must be set at the same height throughout.  
Course design must comply with EQ108.11 except combination is optional.  
Spreads not to exceed fence height.

**Combining/Dividing Sections:**

Age-Group Equitation Sections may be combined as necessary, jumping at their respective heights, to meet the three (3) entry minimum requirement for points to be awarded. Stallions are prohibited when adult equitation sections are combined with children's/junior equitation sections. EQ101.3.

**Awards:** Zone Horse of the Year Awards will be presented annually to the following sections:

Adult Equitation 18-35  
Adult Equitation 36 & Over

## CHILDREN'S HUNTER HORSE

**Sections offered and requirements:** Children's Hunter Horse 14 & Under and Children's Hunter Horse 15-17

**Cross Entry:**

**Rider:** Riders in this sections may enter any Equitation class and may compete with one different horse in the Junior 3'3" Hunter section. Riders may not cross-enter into any Junior 3'6" Hunter or any Jumper class above 1.20m that offers prize money at the same show.

**Horse:** Horses and ponies exhibiting in this section may cross enter multiple sections of Children's Hunter and any classes where eligible.

**Fence Height:**

3'0" with spreads not to exceed the fence height.  
In and outs will be permitted.

**Combining/Dividing Sections:**

The Children's Hunter Horse section may be divided by age of rider. When the Children's Hunter Horse section is divided by age it will be divided: Children's Hunter Horse 14 & Under and Children's Hunter Horse 15-17. If there are fewer than three (3) entries in either age section, the two sections must be combined. The Children's Hunter Horse section may be combined with the Children's Hunter Pony section when there are fewer than three (3) entries in either section. Alternatively, the Children's Hunter Horse section may be combined with the Adult Amateur section when there are fewer than three (3) entries in either section. The Children's Hunter (Horse & Pony) section may be combined with the Adult Amateur section when there are fewer than three (2) entries in either section. When sections are combined and there are more than 24 total entries, the sections must be divided utilizing a Floating split, or a California split to create an even division of entries.

**Classics: Children's Hunter Horse Classics**

Four (4) entries are required to conduct a Children's Hunter Horse Classic. If there are fewer than Four (4) entries an any one Children's Hunter Horse Classic, it may combine with other sections of Children's Hunter Horse or Adult Amateur Hunters. If Children's Hunter Horse Classics are combined and a horse is show in more than one section qualifying for the Children's Hunter Horse Classic, the exhibitor must declare their point section to the Competition Secretary on a declaration form at the time of entry into the classic.

Children's Hunter Horse Classics cannot be divided in any manner and held by section if there are fewer than six (6) entries in each divided section.

**Awards:** Zone Horse of the Year Awards will be presented annually to the following sections:

Children's Hunter Horse 14 & Under  
Children's Hunter Horse 15-17

## LOW CHILDREN'S HUNTER HORSE

### Eligibility:

Open to exhibitors who have not yet reached their 18th birthday as of December 1 of the current competition year.

### Cross Entry:

**Rider:** Riders may not cross enter into any class or section at the same competition where fences exceed 3'3" (Exception: Riders may cross enter into any Equitation classes and Jumper classes 1.15m and below). Riders who compete in the 3' Children's Hunter Horse, Regular A Rated Pony Sections, and/or the 3'3" Junior Hunter classes may show one horse in the Low Children's Hunter.

**Horse and Rider Combination:** Low Children's Hunter horse/rider combinations may not cross enter into any classes or section where fences exceed 2'9".

### Fence Height:

2'6"

### Combining/Dividing Sections:

The Low Children's Hunter section may be combined with the Low Adult Amateur Hunter section when there are fewer than four (4) entries in either section. When sections are combined and there are more than 24 total entries, the sections must be divided utilizing a Floating split, or a California split to create an even division of entries.

**Awards:** Zone Horse of the Year Awards will be presented annually to the following section:

Low Children's Hunter Horse

## CHILDREN'S HUNTER PONY

**Sections offered and requirements:** Small/Medium Children's Pony and Large Children's Pony

### Cross Entry:

**Rider:** Rider age restrictions as found in Regular Pony sections do not apply. Riders may show only one pony in either the 2'0" or the 2'6" height of the Children's Hunter Pony section when also competing in the Regular Small, Medium or Large Pony and/or Green Pony Hunter sections. Riders cannot cross enter into any class where fences exceed 3'3" (exception: Riders may show in Pony Jumpers).

**Horse/Pony:** Ponies exhibited in the Children's Hunter Pony may cross enter into any class where otherwise eligible.

**Horse and Rider Combination:** The rider may not show the same pony in the Regular Pony or the Green Pony Divisions. *Note: The pony may only be shown by one rider in the Children's Hunter Pony Classic and that rider must be declared prior to the first round of the Classic.*

### Fence Height:

Small/Medium Ponies: 2'0" with spreads not to exceed height of fence.

Large Ponies: 2'6" with spreads not to exceed height of fence

In and outs will not be permitted.

### Combining/Dividing Sections:

The Children's Hunter Pony section may be divided by size. If the Children's Hunter Pony is divided by size it will be divided: Children's Hunter Pony Small/Medium and Children's Hunter Pony Large. The Children's Hunter Pony section may be combined with the Low Children's Hunter Pony when there are fewer than three (3) entries in either section, or the Children's Hunter Pony may be combined with the Children's Hunter Horse section when there are fewer than three (3) entries in either section. The Children's Hunter (horse & pony) section may be combined with the Adult Amateur section when there are fewer than three (3) entries in either section. When sections are combined and there are more than 24 total entries, the sections must be divided utilizing a Floating split, or a California split to create an even division of entries.

**Awards:** Zone Horse of the Year Awards will be presented annually to the following sections:

Children's Hunter Pony - Small/Medium

Children's Hunter Pony - Large

## LOW CHILDREN'S HUNTER PONY

### Eligibility:

Open to exhibitors who have not yet reached their 18th birthday as of December 1 of the current competition year. Stallions are prohibited from all Low Children's Pony Hunter classes. Individual classes may be entered.

(Exception: Under Saddle classes. See HU 129.2)

Low Children's Hunter Ponies are not required to jog for soundness.

### Cross Entry:

**Rider:** Low Children's Pony Hunter Riders may not cross enter into any class with fence heights that exceed 2'9" or into the Children's Hunter Pony, Pony Hunter, or Green Pony Hunter Section at the same competition.

**Pony:** Ponies exhibiting in the Low Children's Hunter Pony may cross enter into any class where otherwise eligible.

**Horse and Rider Combination:** The Rider may not show the same Low Children's Pony in the Regular Small, Medium or Large Pony, Green Pony Hunter and/or Children's Hunter Pony sections. A pony may only be shown by one rider in the Low Children's Hunter Pony Classic. In the Low Children's Hunter Pony Classic, the Classic rider must be declared prior to the first round of the Classic.

### Fence Height:

2'0"

### Combining/Dividing Sections:

Combining: If there are fewer than three (3) ponies in the Low Children's Hunter Pony section, they may combine with the Children's Hunter Pony Section.

Dividing: Low Children's Hunter Pony may be divided if there are more than 20 entries in the Division.

**Awards:** Zone Horse of the Year Awards will be presented annually to the following sections:

## JUNIOR JUMPER

### Sections offered and requirements:

1.00m/1.05m Junior Jumpers

1.10m/1.15m Junior Jumpers

### Cross Entry:

Competition Management may restrict cross entries between 1.10m/1.15m and 1.00m/1.05m sections at the same competition if stated in the prize list.

**Rider:** Any competitor that competes in any class set at over 1.25m is ineligible to compete in an Junior Jumper class set below 1.20m at that competition. Competitors competing in a 1.00m/1.05m Junior Jumper Classic or a 1.10m/1.15m Junior Jumper Classic may not compete in any other Jumper Classic above 1.15m at the same competition.

**Horse and Rider Combinations:** 1.00m/1.05m Junior Jumper horse/rider combinations may not cross enter into any classes held above 1.15m at the same show. 1.00m/1.05m Junior Jumper horse/rider combinations may enter only one classic, if both 1.00m/1.05m and 1.10m/1.15m are offered.

1.10m/1.15m Junior Jumper horse/rider combinations are not permitted to cross enter into Junior Jumper classes or any class at 1.20m and above, these horse/rider combinations are also not permitted to cross enter any jumper classes at 1.20m and above that offers prize money at the same competition. 1.10m/1.15m Junior Jumper horse/rider combinations may enter only one classic, if both 1.00m/1.05m and 1.10m/1.15m are offered.

### Fence Height:

Junior Jumper 1.00m to 1.05m

Junior Jumper 1.10m to 1.15m

### Combining/Dividing Sections:

1.00m/1.05m Junior and 1.10m/1.15m Junior Jumper sections may be divided or combined with 1.00m/1.05m Amateur Jumper and the 1.10m/1.15m Amateur Jumper sections, at management's discretion, if so stated in the prize list.

**Awards:** Zone Horse of the Year Awards will be presented annually to the following sections:

1.00m/1.05m Junior Jumper

1.10m/1.15m Junior Jumper

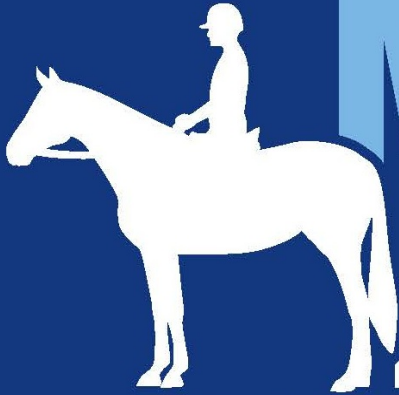
